September 5, 2019 Meeting with the Chinese delegation





As part of the Chinese delegation visit, a second working meeting was held at Kutafin Moscow State Law University (MSAL). The University was represented by the First Vice-Rector Elena Gracheva, the Head of International Cooperation Department Maria Egorova, Chief Editor of the magazine "Current problems of Russian law", participant of the North-East Asia Legal Exchange Program of the Chinese Legal Community in 2018 Alexander Sitnik and the Vice-Rector for International Cooperation Dmitry Kutafin.

Among the Chinese colleagues were Yin Baohu – Director-General of the China Exchange Legal Center, Guo Shasha – Member of the Central Political and Legal Affairs Commission of the Communist Party of China, Yang Yong - Deputy Secretary of the Political and Legal Affairs Commission of the Sichuan Provincial Communist Party of China Committee, Wei Lisha – Program Officer of the International Department of the Chinese Legal Community.

Participants discussed various areas of international cooperation: opportunities for students exchange, interaction in research activities, publication of scientific articles of MSAL professors in law journals of the PRC, joint scientific workshops (including webinars), round tables and conferences as well as participation of Chinese representatives in editorial boards of the MSAL scientific journals.

The meeting was followed by a lecture of Yang Yong, Deputy Secretary, Political and Legal Affairs Commission of the Sichuan Provincial Communist Party of China Committee, on "China's New Measures to Guarantee the Development of Private Enterprises".



September 14-19, 2019 II International Legal Forum in Cannes (France) "Modern Problems of Law and Economics in Europe and Asia"

November 27, 2019
Round table "Current problems
of legal cooperation between Russia and France"



On the second day of the XVII International Scientific and Practical Conference "Kutafin readings" MSAL hold round table "Current problems of legal cooperation between Russia and France". The event began with the opening statement of Maria Egorova, Head of International Cooperation Department of MSAL, Deputy Chairman of the Executive Committee of the Moscow Regional Branch of Association of Lawyers of Russia, Co-President of the International Alliance of Jurists and Economists (France, Lyon):

"Thank you all for your interest in participating in our scientific discussion. The round table is held within joint XX International Scientific and Practical Conference of the

Law Faculty of Lomonosov Moscow State University and XVII International Scientific and Practical Conference "Kutafin readings" and coincides with the IX Moscow Law Week. During the three days of the Forum, more than 50 round tables and panel discussions will be held, world leading legal experts are invited. Our round table will be focused on consideration of current problems of legal cooperation between Russia and France. Historical tradition unites our countries, Russia and France have a long-standing history of educational cooperation and dozens of joint educational programs."

The Chairman of the Association of Russian Diplomats, Member of Committee of Experts on Public Administration of ECOSOC UN, PhD in Economics, Igor Khalevinsky commented that International Alliance of Jurists and Economists is a part of civil society, an expert community that united with a purpose of comprehension of global processes:

"When we signed an agreement with the Alliance, I was told it was the future of the world. We are working on this triad, promoting international projects and strengthening Russian-French ties. We are pleased to cooperate with Kutafin Moscow State Law University (MSAL) because here is the best expert community and the greatest field for international activity" – concluded Igor Khalevinsky.



The growing popularity of legal cooperation between Russia and France was described in the speech of the Justice Attaché at the French embassy in Russia Alain Duflot.

"I have a rather optimistic topic, because international ties between Russia and France are developing quite successfully this year. An agreement between the Supreme Court of the Russian Federation and the French Constitutional Court is currently being drafted. It is also planned to conclude cooperation agreement between the Ministries of Justice. All this was made possible through strengthening the political interaction. The meeting between Vladimir Putin and Emmanuel Macron was an oc-



casion to enhance partnership in both the technical and legal spheres. What are the goals and areas of legal cooperation? First, the re-establishment of ties between organizations in various fields of law. Secondly, protection of our common values and the incorporation of international and European norms"

The Dean of the Faculty of Law and Political Science at University of Lumière Lyon II Guillaume Protière continued the agenda. His overview included the complexities of constitutional law in regulating economic processes and analysis of different historical periods in terms of the law:

"Since about the 1980s in France the force of law and rules is increasing, the international, political, economic context are changing, the WTO and the EU are emerging. Private law needs to be protected and legal mechanisms for influencing the economy are being developed.

For several decades, these clear provisions and liberal principles have been evolving in France. However, there are still some difficulties, contradictions in economics and state power. This is especially evident in the context of increasing globalization".

The speech of Fabrice Rosa, PhD in Law, Associate Professor of Private Law at the University of Reims Champagne Ardenne, Director of CEJESCO, was devoted to Franco-Russian comparative law: "Challenges and institutional framework".

The event included the lecture of Fabrice Rosa, PhD in Law, Professor of private law at the University of Reims Champagne Ardenne, Director of CEJESCO, on "Legal status of employees in a digital economy: prospects in French law".

Mario Antinucci, Associate Professor at the SAPIEN-ZA University, Head of International Relations at Order of the Lawyers of Rome & VP of SIRIUS GLOBAL, explained general principles of the European Union's due process of law.

"Artificial Intelligence and the Blockchain Technology in the Creative Arts Industry" were presented by Gabriella Marcelja, President of SIRIUS GLOBAL – International Research Hub – leading international NGO, operating in the sector of education, culture, science and innovation.

Participants considered key legal instruments and discussed all the questions.

February 6, 2019 Lectures of French experts



February 6 as a part of the visit of the French delegation MSAL hosted lectures of French experts in international law Daniel Guyot and Estelle Fohrer-Dedeurwaerder.

Lectures were organized by International Cooperation Department. The Head of ICD Maria Egorova opened the event.

Maria Egorova stressed the importance of the Russian-French scientific cooperation, and also thanked the assistant to the rector of Kutafin University (MSAI) for international activity Andrey Ivanov for his scientific and organizational assistance in conducting this event.

Daniel Guyot, Arbitrator of the International Commercial Arbitration Court at the Russian Federation Chamber



of Commerce and Industry, Member of the French Society of Comparative Law, described the immunity of a foreign State in French practice.

It was explored the historical formation of the immunity of foreign State in international law and contemporary practice. Special attention was paid to known Russian cases involving State immunity in international law.


The second lecture focused on the ratio between European Union law and French constitutional law. Professor at University Toulouse 1 Capitole, Co-Director of European School of Law, Estelle Fohrer-Dedeurwaerder explained the application of supremacy of European law as well as the practice of the French Constitutional Council and the French supreme courts.

February 7, 2020 Lecture "Criminal Migrants in Limbo"

February 7 MSAL held the lecture "Criminal Migrants in Limbo" given by Joris van Wijk, Associate Professor at the Law Faculty's Department of Criminal Law and Criminology at VU Amsterdam, expert in criminology, international criminal law, specialist in criminology, international criminal law.

The event was organized jointly with Nuffic Neso Russia (the official representative of Dutch higher education in Russia) and the MSAL International Cooperation Department. The lecture was opened by Maria Egorova, Head of the MSAL International Cooperation Department.

Lecturer considered in detail the phenomenon of "undesirable and unremovable immigrants in limbo". Such



The origins of this phenomenon were analyzed in the stories of specific people. The lector identified the following categories of most frequently involved in this situation: war criminals who have committed crimes in the territory of another state, suspected terrorists, suspected pirates, foreign fighters, etc. A review of the history showed that since the 1900s, especially since the Second World War, the number of Criminal Migrants in Limbo has increased dramatically. In addition, professor provided with statistics on the settlement of the problem.

At the end of the lecture, Joris van Waik presented possible options for resolving the uncertainty of criminal migrants in limbo and suggested questions for discussion.
